## MOLLY CULHANE ELECTED TO WRESTLE LIKE A GIRL'S BOARD OF TRUSTEES

(WASHINGTON, DC) – Wrestle Like A Girl (WLAG) announced today that Molly Culhane was elected to the Board of Trustees and will serve as Treasurer. Ms. Culhane, Senior Vice President and Mid-Atlantic Director for Amalgamated Bank is the co-founder of the Bank's political banking sector. As the head of the Mid-Atlantic Region, Ms. Culhane has managed the largest commercial deposit growth experienced by a region of the bank in its entire 98-year history. In her current role, Ms. Culhane is also active in developing and implementing the strategic goals for the region, which include overseeing existing and new business lines.

Prior to the White House, Ms. Culhane was the founding Chief Financial Officer of President Obama's non-profit organization, Organizing for Action. Ms. Culhane assumed that role after serving as the National Budget Director and Deputy Chief Financial Officer of President Obama's reelection campaign, where she allocated and managed a \$1.2 billion budget. Before moving into the political sector, Ms. Culhane spent almost a decade at The Boeing Company in various roles, the last position as an analyst with the National Security and Space Group. She came to Boeing after serving as a financial analyst for Mitchell Madison Group in London.

WLAG's CEO Sally Roberts said, "We are honored to have Molly join the WLAG Board of Trustees and be a shepherd of the women's wrestling movement. Along with her passion to empower girls and women to be leaders in life, she has expertise in fundraising that will help build capacity for WLAG so that its impact will be continue to be felt for generations to come." Ms. Culhane earned a Bachelor of Science degree in History from the University of Wisconsin, Madison, and studied for a master's degree in Public Policy and Administration, with a specialization in National Security Policy from Northwestern University.
